- Educate, train and motivate staff to work in an environmentally responsible manner and to play a full part in developing new ideas and initiatives to ensure a committed and competent workforce.
- Endeavour to ensure that natural resources and materials used in our construction operations are sourced from sustainable supplies.
- Reduction, reuse and recycling of materials will be promoted and receive active ongoing consideration, as will the effects of transporting plant, equipment and materials on the environment.
- When used that timber products, are recycled or from well-managed, sustainable sources and are Forest Stewardship Council (FSC) certified.
- Minimise waste and ensure waste streams are segregated for recycling.
- Continually look for reduction in energy use, improved energy efficiency and carbon reduction.
- Review all sub-contractors and suppliers before appointment to ensure that they also understand and conform to their environmental responsibilities for each contract.
- Continue to further develop our presence in the sustainability market.
